PARENT APPLICATION FOR STUDENT GRANT (1 per family)

- Only ONE application from each family is required.
 - The form must be completed in its entirety and signed.
 - There MUST be a legitimate form of income substantiation for the household from which each child who is selected to participate in the Tuition Grant Program resides. Acceptable forms of income substantiation include:
 1. Official document verifying eligibility for the free/reduced price lunch program.
 2. 2019 Federal Income Tax Return Form 1040 including a dependent statement listing the child receiving the Tuition Grant Award (if the child is not listed as a dependent on the 1040, a signed letter from the Head of the School explaining the circumstances must be included). (Copies of other supporting IRS schedules are not required).
 3. Official FACTS Grant & Aid Assessment income verification document.
 4. Official document verifying eligibility for welfare/and/or food stamps.
 5. Social Security Form 1099 (or equivalent) verifying social security income (if this is the household's sole source of income, a signed letter from the Head of the School explaining the circumstances must be included.)
- **The omission of some type of income substantiation will result in the denial of that child's Tuition Grant Award.
