REGISTRATION PAYMENT PREFERENCE

The annual registration fee is \$420 per student and may be paid in full or billed in three monthly installments. The registration fee encompasses the Office of Catholic Schools fee of \$71 (which includes accreditation, administrative (Rediker), and Catholic Schools Week). The remaining \$349 goes toward St. Benedict Catholic School (to cover textbooks, workbooks, technology, supplies, testing, and capital assessment fees) **Please choose preferred REGISTRATION FEE payment option:**

- Full payment** - \$420 per student paid in full via check or cash and delivered directly to St. Benedict by March 12th, 2021
- Monthly installments**- Payment will be made over a three month period via the FACTS online payment system (log into your FACTS account to make payments or set up a new FACTS account through link on the school website under Admissions | Payment & Tuition Information). Invoiced on March 12th, April 12th, and May 12th (through FACTS incidental billing option)

TUITION PAYMENT PREFERENCE

SBCS tuition payments may be paid in full or divided into 2, 10, or 12 month payment options. Annual tuition rate for PreK3 & 4 is \$4500 per student (both Catholic & non-Catholic rate). The annual tuition rate for Kindergarten through 8th grades is \$4,000 per student (reflects discount for practicing Catholics) and \$5,000 per student (non-Catholic). Add \$3,000 for each additional student (practicing Catholic) or \$4,000 for second student (non-Catholic) and \$3,550 for third student (non-Catholic). Please contact the office for any additional questions or for financial aid assistance options. **Please choose preferred TUITION FEE payment option:**

- Full payment** - Annual tuition rate will be paid in full via check or cash directly to St. Benedict by August 5th, 2021
- Two FACTS payments**- Tuition will be paid in 2 payments in Aug 2021 & Jan 2022 in FACTS tuition payment option
- Ten FACTS payments** - Tuition will be paid in 10 payments monthly beginning Aug 2021 in FACTS tuition payment option
- Twelve FACTS payments** - Tuition will be paid in 12 payments monthly beginning Aug 2021 in FACTS tuition payment option

TUITION & HANDBOOK AGREEMENT WAIVER

Any disputes arising out of or relating to this Agreement, performance under this Agreement, or the breach thereof, including all disputes of any nature relating to my child(ren)'s enrollment and attendance at this school, and including but not limited to the threshold questions of arbitrability and the formation of this arbitration agreement shall be finally resolved by binding arbitration administered by the American Arbitration Association under its rules, and judgement upon the award rendered by the arbitrator may be entered in any court having jurisdiction. The arbitration shall be conducted in the English language in the city of Mobile, Alabama, applying the laws or the State of Alabama. There shall be one arbitrator who shall be selected in accordance with the procedures of the American Arbitration Association. Each party shall pay one half of the cost of the arbitrator. In event shall punitive damages be awarded by the arbitrator in favor of either party, unless specifically authorized by applicable statute. This provision is continuing in nature and shall remain in force throughout the entire period of my child's enrollment at this school.

BY MY SIGNATURE BELOW, I AGREE TO SEND ANY AND ALL DISPUTES RELATING TO THIS AGREEMENT, TO BINDING ARBITRATION.

I ALSO HEREBY WAIVE MY RIGHT TO A JURY TRIAL IF A DISPUTE ARISES IN ANY WAY RELATING TO THIS AGREEMENT. I ALSO AGREE TO ABIDE BY THE SCHOOL HANDBOOK (SEE SAINTBENEDICT.NET FOR HANDBOOK), WHICH IS IN KEEPING WITH CATHOLIC TEACHINGS.
