REGISTRATION PAYMENT PREFERENCE

The annual registration fee is \$450 per student and may be paid in full by March 1st or billed in three monthly installments. Please choose your preferred registration payment option below.

- Full payment** - \$450 per student paid in full to secure registration.
- Monthly installments**- Payment will be made over a three month period via the FACTS online payment system (log into your FACTS account to make payments or set up a new FACTS account through link on the school website under Admissions | Payment & Tuition Information). Invoiced on February 1st, March 1st, & April 1st (through FACTS incidental billing option).

TUITION PAYMENT PREFERENCE

SBCS tuition payments may be paid in full or divided into 2, 10, or 12 month payment options. Please contact the office for any questions or for financial aid assistance options. Please choose your preferred tuition payment option below.

- Two FACTS payments**- Tuition will be paid via the two payment option within FACTS
- Ten FACTS payments** - Tuition will be paid via the ten payment option within FACTS

TUITION & HANDBOOK AGREEMENT WAIVER

Any disputes arising out of or relating to this Agreement, performance under this Agreement, or the breach thereof, including all disputes of any nature relating to my child(ren)'s enrollment and attendance at this school, and including but not limited to the threshold questions of arbitrability and the formation of this arbitration agreement shall be finally resolved by binding arbitration administered by the American Arbitration Association under its rules, and judgement upon the award rendered by the arbitrator may be entered in any court having jurisdiction. The arbitration shall be conducted in the English language in the city of Mobile, Alabama, applying the laws or the State of Alabama. There shall be one arbitrator who shall be selected in accordance with the procedures of the American Arbitration Association. Each party shall pay one half of the cost of the arbitrator. In event shall punitive damages be awarded by the arbitrator in favor of either party, unless specifically authorized by applicable statute. This provision is continuing in nature and shall remain in force throughout the entire period of my child's enrollment at this school.

BY MY SIGNATURE BELOW, I AGREE TO SEND ANY AND ALL DISPUTES RELATING TO THIS AGREEMENT, TO BINDING ARBITRATION. I ALSO HEREBY WAIVE MY RIGHT TO A JURY TRIAL IF A DISPUTE ARISES IN ANY WAY RELATING TO THIS AGREEMENT. I ALSO AGREE TO ABIDE BY THE SCHOOL HANDBOOK (SEE SAINTBENEDICT.NET FOR HANDBOOK), WHICH IS IN KEEPING WITH CATHOLIC TEACHINGS.
